

# CAPITAL GOODS SKILL COUNCIL (CGSC)

## REQUEST FOR QUOTATIONS- RFQ/FEB2018/001 FOR DEVELOPMENT OF NEW QUALIFICATION PACK

### 1. Scope of Work

CGSC invites Quotation for development of 3 new QPs. The agency developing new Qualification Pack would be required to

1. Carry out a market scan and demand forecast both in short term and long term for the new QP with support from CGSC.
2. Identify any regulatory or statutory requirement applicable for the QP.
3. Develop new QP/s and Q Files as per NSDC QRC/NSQC guidelines. The Industry Validations of new QP will be undertaken by CGSC; however the agency involved will be undertaking modifications as per industry inputs.
4. Support CGSC in QRC and NSQC approval.
5. Suggest necessary changes /update in the existing Occupational Map based on serial 1

### 3. General Instructions

- The firms / agencies may send Quotation as Individual, Firm/s or Consortia, giving out the details of the partnership model.
- Must have a Permanent Account Number (PAN) from Income Tax authorities.
- All the communication to CGSC including the Quotation shall be signed by the authorized representative of the Firm / Agency / Consortia on letter head
- Information which is considers proprietary, should be clearly marked "proprietary" next to the relevant part of the text and it will then be treated as such accordingly.
- The final selection and agreement with the shortlisted agency will be as per CGSC guidelines.

### 4. Rights of CGSC

- At any time, CGSC may, for any reason, change the last date/timelines of RFQ.
- The amendment will be intimated to all proposers who confirm their intention to participate, by email.
- CGSC may cancel the RFQ at any time without assigning any reason.
- CGSC may ask for fresh RFQ if found necessary.
